RESOLUTION 2022-441

A Resolution Setting Forth the Monthly Water Rates, Late Fees, Certified Mail Penalties and Service Charges

BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF ROLLING HILLS, WYOMING, THAT:

WHEREAS, Wyoming Statutes mandate that it is necessary for the Governing Body of the Town of Rolling Hills to ensure that there are sufficient funds to operate and repair the water system within the Town; and,

WHEREAS, the only equitable method of apportioning the cost of operation and repair is through water rates, fees, penalties and service charges.

NOW THEREFORE, THE FOLLOWING IS HEREBY RESOLVED BY THE GOVERNING BODY OF THE TOWN OF ROLLING HILLS, WYOMING:

- 1. The monthly water rates are set forth as follows until such time as the Governing Body deems an appropriate change is necessary:
 - a. For residential properties within the limits of the Town of Rolling Hills -

\$42.00 per month for a service fee.

\$0.00 for the first 1,000 gallons of water

\$3.00 per each 1,000 gallons over 1,000 gallons up to 5,000 gallons

\$3.25 per each 1,000 gallons over 5,000 gallons up to 10,000 gallons

\$3.50 per each 1,000 gallons over 10,000 gallons up to 20,000 gallons

\$4.00 per each 1,000 gallons over 20,000 gallons up to 50,000 gallons

\$4.50 per each 1,000 gallons over 50,000 gallons up to 100,000 gallons

\$5.00 per each 1,000 gallons over 100,000 gallons up to 120,000 gallons

\$5.50 per each 1,000 gallons over 120,000 gallons

b. For residential properties not located within the Town of Rolling Hills -

\$57.00 per month for a service fee.

\$0.50 for the first 1,000 gallons of water

\$3.50 per each 1,000 gallons over 1,000 gallons up to 5,000 gallons

\$3.75 per each 1,000 gallons over 5,000 gallons up to 10,000 gallons

\$4.00 per each 1,000 gallons over 10,000 gallons up to 20,000 gallons

\$4.50 per each 1,000 gallons over 20,000 gallons up to 50,000 gallons

\$5.00 per each 1,000 gallons over 50,000 gallons up to 100,000 gallons

\$5.50 per each 1,000 gallons over 100,000 gallons up to 120,000 gallons

\$6.00 per each 1,000 gallons over 120,000 gallons

For commercial businesses on the Town of Rolling Hills distribution system c.

\$42.00 per month for a service fee.

\$2.00 for the first 1,000 gallons of water

\$3.00 per each 1,000 gallons over 1,000 gallons up to 5,000 gallons

\$3.25 per each 1,000 gallons over 5,000 gallons up to 10,000 gallons

\$20.00 per each 1,000 gallons over 10,000 gallons up to 25,000 gallons

\$30.00 per each 1,000 gallons over 25,000 gallons up to 50,000 gallons

\$40.00 per each 1,000 gallons over 50,000 gallons up to 75,000 gallons

\$50.00 per each 1,000 gallons over 75,000 gallons up to 100,000 gallons

\$60.00 per each 1,000 gallons over 100,000 gallons up to 125,000 gallons

\$70.00 per each 1,000 gallons over 125,000 gallons up to 150,000 gallons

\$80.00 per each 1,000 gallons over 150,000 gallons up to 175,000 gallons

\$90.00 per each 1,000 gallons over 175,000 gallons up to 200,000 gallons \$100.00 per each 1,000 gallons over 200,000 gallons

- 2. A late fee in the amount of Ten Dollars (\$10.00) will be assessed to accounts that are not timely paid by the due date as stated on the monthly water bill.
- 3. A penalty in the amount of Twenty Dollars (\$20.00) will be assessed to accounts that are not timely paid and to which a certified past due notice is mailed.
- 4. A service fee in the amount of Thirty Dollars (\$30.00) will be assessed to accounts for each call-out made by the water operator at the request of the occupant or a town official, or by any other individual due to an emergency.
