Proposed methodology for the Rolling Hills Town Hall & Mailbox Facility are as follows:

Step one on the project will consist of excavation, removal and disposal of any excess fill material. Upon completion of all areas being excavated grading "W" base will be installed and any formwork or rebar work will begin once base has been installed and compacted. After the base has been compacted, forms & rebar have been completed, concrete will be figured and ordered for each location. After the concrete placement has been completed and curing compound has been applied the next steps typically the following day will be site cleanup and demobilize from the location. Projected timeline for this scope start to finish is 3-5 business days.
